THE FEDERAL ARBITRATION ACT WILL APPLY TO THE INTERPRETATION AND ENFORCEMENT OF THIS SECTION. YOU AND SELLER (USA), LLC AGREE NOT TO JOIN OR CONSOLIDATE CLAIMS, AND EACH PARTY MUST PROCEED INDIVIDUALLY. IN THE EVENT OF A DISPUTE, THE ARBITRATOR WILL HAVE AUTHORITY TO GRANT RELIEF UNDER LAW OR EQUITY. ANY AWARD BY THE ARBITRATOR WILL BE FINAL AND BINDING. These Terms shall remain in effect after a written notice has been posted on the Site. Waivers: If Seller does not enforce or delay enforcing any right or remedy under these Terms, it will not be considered as waiving that right or remedy. However, only a written waiver signed by Seller and specifically mentioning each right or remedy being waived shall be effective. Seller's failure to exercise a right or remedy does not imply its abandonment. Only Seller's written consent can allow Customer to assign rights or obligations under these Terms. Customer cannot transfer any of their rights or duties without first obtaining the written approval from Seller. Any attempt by Customer to do so will have no effect. To ensure optimal results when using the pressure cooker, follow these guidelines: - For cooking proteins like meats and fish, use the High setting. - For cooking grains, such as brown rice or wild rice, use a longer pre-soaking time in conjunction with low to medium heat levels. - For making porridge or congee, select a medium heat level for a more uniform consistency. - When steaming vegetables or seafood, choose a lower heat setting to prevent overcooking and maintain texture. - If sterilizing baby items, use the lowest pressure setting possible; for pasteurizing dairy products or canning acidic foods, adjust the heat accordingly. - For cooking yogurt, pick a medium heat level to achieve the desired consistency without overheating the milk. - When keeping food warm at different serving temperatures, select from three available temperature settings.
